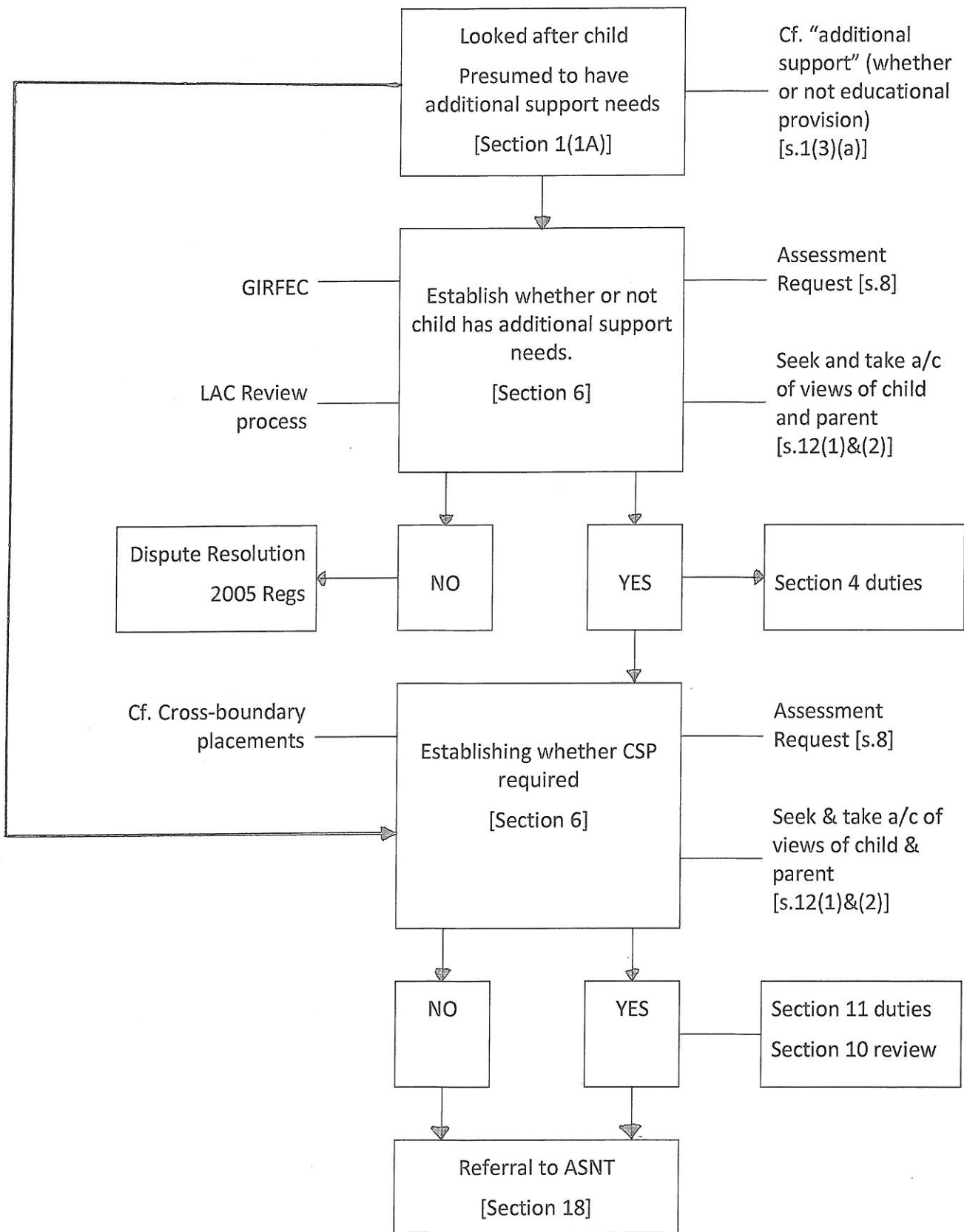


Looked after children and additional support needs flowchart



Authority

(a) The number of children looked after by your local authority (within the meaning of s.17(6) of the Children (Scotland) Act 1995)

 (ii) the number in respect of whom the authority have considered whether they require a Co-ordinated Support Plan, in compliance with s.6(1A) of the Education (Additional Support for Learning) (Scotland) Act 2004; and
 (iii) the number who have a Co-ordinated Support Plan.
